1. Introduction

The residents of Plock and Plock County participated in a series of informational meetings on the construction of the Olefins III Complex organized by ORLEN S.A. (hereinafter ORLEN). Experts from the investor, ORLEN, and the project contractor, a consortium of companies Hyundai Engineering and Técnicas Reunidas, spoke about the ongoing project and answered questions from the meeting participants.

During the series of public meetings with the local community, held over several days in February at various locations and convenient times of the day, the potential of the venture for the national economy, but also for the local market, was discussed. Participants learned about construction progress and involvement of national and local companies, as well as development opportunities for local stakeholders. During the meetings, anyone could ask a nagging question and raise any topic related to the construction of the Olefins III Complex, and the experts explained all issues in detail.

The residents attending the meeting were also presented with the main environmental and social aspects as well as documents under which the investment is being implemented. Among other things, the analysis of the investment's impact on the immediate environment, the Stakeholder Engagement Plan - SEP, the Social Impact Assessment - SIA and the Human Rights Impact Assessment - HRIA were discussed.

The meeting participants also learned about the environmental impact assessment prepared in accordance with the Law on Providing Information on the Environment and its Protection, Public Participation in Environmental Protection and Environmental Impact Assessments.

Community-oriented activities carried out in Plock County and Plock were also discussed. The Environmental Protection Office managers spoke about issues related to maintaining environmental standards, while a representative of the Group OHS and Prevention Coordination Department spoke about those related to safety standards at the construction site.

In order to ensure a response to all notices, questions and complaints - especially those from people representing the local community - a special contact form has been introduced on the Olefins III construction implementation page, which was presented

during the meetings. The Local Community Relations Officer was also present at the meetings.

2. The course of consultations with residents

The first meeting was held in the conference room of the Education Center in Plock. The second meeting took place at the Elementary School in the Trzepowo district adjacent to the Production Plant, and the last meeting was held at the sports and entertainment hall in Maszewo Duze, located in the municipality of Stara Biala and bordering Plock. The next section describes the dates and places of meetings in detail.

2.2. Information provided at meetings

Each meeting had the same structure, i.e. the meetings began with the presentation

entitled: "Olefins III Complex construction - potential of the Project" and next with a

presentation on the impact of the investment on the environmental and social surrounding.

The presentations were followed by an open question and answer session. Below is a

summary of the presentations mentioned, which constitute appendices to the report.

3. Presentation of the project "Olefins III Complex construction - potential of the Project" and

the investment's impact on the environmental and social surrounding presented by ORLEN

S.A. representatives.

During the meetings, residents received a set of information on the implementation

of the investment, its preparation, progress and continuation.

The following order was followed at each of the three meetings:

a) presentation entitled "Olefins III Complex construction - potential of the Project";

ORLEN S.A.

b) presentation on the key environmental and social principles included in the Project.

Each meeting was opened by Damian Olewnik, Director of the Olefins Production Intensification Office, who introduced the participants to important issues such as:

- exact purpose of the investment the construction of a plant for ethylene, propylene,
 ethylene oxide, glycols, styrene extraction, hydrogenation of pyrolysis gasoline;
- investment schedule, broken down into stages;
- examples of the use of individual products of the new installation;
- investment 3D model:
- progress of design, procurement and construction work;
- sources of supply;
- importance of the investment for domestic and international entrepreneurs;
- importance of the investment for the local community, municipality, entrepreneurs and contractors.

Afterwards, Arkadiusz Ciesielski, a representative of the Local Community Relations Team, continued the meeting with a presentation on the key environmental and social principles guiding the Company's implementation of the Project, introducing the following issues to participants at all three meetings:

- environmental and social principals:
 - implementation of the investment in accordance with applicable standards and laws;
 - project implementation based on norms and international standards;
 - application of precautionary principles in relation to the impact on the environment, health and human life, respect for labor and human rights;
 - monitoring the work environment based on OHS principles;
 - o open dialogue with stakeholders and maintaining good relations with them, building positive relations with the local community and government bodies.
- activities involving the highest standards in the following categories:

- legal principles and standards;
- relations with the surroundings;
- environment;
- employees and the work environment;
- o industry standards.
- As part of the legal basis, information on the environmental impact report was presented in accordance with the Law on Providing Information on the Environment and its Protection, Public Participation in Environmental Protection and Environmental Impact Assessments. This report was prepared in accordance with the Act of October 3, 2008 on the provision of information on the environment and its protection, public participation in environmental protection and environmental impact assessment. The project has received a positive decision on environmental conditions from the Head of the Stara Biala Municipality (document dated 10 February 2023, reference no. RGK 6220.31.2021). Information on obtaining a positive decision dated 18 August 2023 (reference no. 69/LOK/2023) on the location of the investment issued by the Mazovian Governor was also provided.
- Next, activities related to nurturing relationships with the surroundings were presented. All activities related to developing relations with the surroundings are based on the Stakeholder Engagement Plan. During the meetings, publicly available events organized to maintain good relations and provide the local community as well as the city and municipal authorities with information on investments were discussed:
 - o "Vistula family cruises" [Rodzinne rejsy po Wiśle], meaning boat trips on the Vistula River organized on August and September 2023. Cruise participants learned a lot of practical information about the constructed Olefins III Complex from the brochure distributed. During the cruises, music was broadcast and dishes from the contract workers' home countries were distributed.
 - o An informational and educational campaign in the form of 19 meetings in Plock schools organized by ORLEN and the police, dedicated to countering stereotypes, hate

and hate speech, organized under the slogan "Respect has no color" [Szacunek nie ma

koloru] and meetings for the local community organized on August 2023, during which

exotic cuisines of contractors' countries were popularized.

o Participation in meetings of the Commission of the City Council of Plock

(Committee for Municipal Economy and Investment, Development and City Safety, as well

as Treasury, Budget and Financial Management) and the Council of the Stara Biala

Municipality, i.e., meetings with key stakeholders.

o "Meetings with Culture" [Spotkania z Kultura] at the Plock Public Library, part of

an information campaign about the Olefins III Complex investment and the "ORLEN as a

good neighbor" [ORLEN dobrym sąsiadem] program. It took place on November and

December 2023 and January 2024. The meetings focused on the culture and literature of

the contract workers' countries, namely Spain, Turkey and India. Invited experts talked

about the culture of the countries mentioned, while employees of the Olefins III Complex

construction site read excerpts of works in their native language.

o Activities carried out under the "ORLEN as a good neighbor" program: a donation

to the Voluntary Fire Brigade Units of Stara Biala Municipality for the purchase of

defibrillators; medical consultations and free examinations of senior citizens living in the

vicinity of the Production Plant as part of the "Say YES to a healthy future" [Powiedz TAK

zdrowej przyszłości] campaign; lessons for schoolchildren from the Stara Biala

Municipality in the mobile chemistry knowledge laboratory "NaukoBus" organized on

October 2023; a donation of PLN 142 million to the Stara Biala Municipality for the

reconstruction of selected county roads;

Social Impact Assessment based on the SIA report;

• Implementation of the provisions of the SIA report by:

o implementing the Human Rights and Work Rules Policy in the Project Supply

Chain;

o conducting open communication with the public through the local media, the

investment website, and organizing community-oriented activities;

- identifying transportation routes to minimize the number of trucks in built-up areas;
- o introducing supervision of working conditions at the construction stage;
- provision of medical care at the site supervision of medical personnel in the outpatient clinic with an ambulance;
- o creation of accommodative sanitary and social facilities;
- Implementing the Project in accordance with the HRIA report related to the impact of the Olefins III Project on human rights:
 - o Human Rights Protection Policy in the ORLEN Capital Group;
 - safety management;
 - o activities to raise sensitivity to discrimination and prejudice.
- Development of the Safety and Health Protection Plan (SHPP).
- Representatives of the Environmental Protection Office presented the issue of securing the environment. The "Decision on environmental conditions" was preceded by obtaining the necessary opinions and agreements, among others with the Marshal's Office, the Regional Directorate of Environmental Protection, the Chief Sanitary Inspectorate and the State Water Holding Polish Water (Wody Polskie). The technology most favorably aligned with environmental, business and technical goals was adopted for the project, and the selected construction site was an undeveloped area, which has the following advantages:
 - o use of lands that have not been used so far, and located within the industrial building zone;
 - o no necessity to occupy non-industrial lands and conduct expropriation;
 - o access to the infrastructure ensuring more effective use of utilities;
 - access to qualified plant personnel;
- The feedback and complaint mechanism, created for the project and posted on the project website, developed to facilitate communication with stakeholders, including Project executors, was presented;



- Director Lukasz Agacinski discussed the OHS and the fire protection activities:
 - ORLEN S.A. OHS service employees are available at the site on a full-time basis every day;
 - OHS service personnel on the part of contractors and their subcontractors are required;
 - since construction commencement, 7 million man-hours have passed without an accident at the project site;
 - o an ambulance and a police station are available at the project site 24 hours a day;
 - o first aid training is conducted once a month;
 - once a year, the entire construction site is evacuated, and the evacuations of individual construction sections are conducted more frequently;
 - o each employee is obliged to pass OHS tests

After the presentation, residents were encouraged to participate in the discussion and ask questions. Meeting participants were eager to take part in the discussion and share their opinions.

The world's best technology for ethylene and propylene production was used. The director assured that the company had made every effort to select technology for the new plant.

ORLEN has no influence on the operation of state environmental monitoring. Private entities do not participate independently in state monitoring. information that the subcontractors were selected on the basis of tenders available to all domestic as well as global companies. Hyundai, as a multinational company and one of the largest players in the market, was aware that the implementation of an investment in a city like Plock would be associated with great responsibility on the social side. In order to find optimal logistical solutions for commuting to work, it was decided at the beginning to create an employee town located on the investment premises. Accordingly, a container town with 6,000 beds has been built adjacent to the investment. If not for the container town, there would be traffic jams in the city. Director Jakub Zgorzelski stressed that surely each of us has someone in our circle who has gone to work abroad in Poland. He pointed out that employees leaving for work want, just as everyone else, to spend their free time normally, going out for walks, playing their favorite games. Each of them has the right to function normally outside working hours. For example, he stated that the Filipinos present in the workers' town hold sports tournaments every weekend on a specially built field, as do representatives of other countries. The subcontractors that won the tenders are Polish, European and Asian companies. Diversifying the subcontractors will allow us to meet contractual requirements related to the investment implementation schedule. He added that it would be impossible to find a sufficient number of qualified workers solely in the Polish market. Finally, he emphasized that police statistics do not indicate an increase in criminal activity in and around Plock. Both



			ORLEN and the CHT group, the investment contractor, are in constant contact with representatives of local authorities. Regular meetings are held with local and provincial authorities to discuss the current situation. Afterwards, Director Damian Olewnik exchanged phone numbers with the resident to clarify the accommodation of foreign workers in the nearby village of Gulczewo in the following days.
			At the end of the meeting, residents were informed that each of the contract workers received informational and educational materials about customs and culture in Poland, meaning what is allowed and what is prohibited. Each of the employees is staying in Poland legally. Any company that wants to obtain a work permit for its employees must be registered in Poland. Every foreigner must apply for a work permit and then for a visa and appear for an interview with the consul. Each potential employee is thoroughly vetted by security services. Only after obtaining a visa can the employee come to Poland.

However, one must keep in mind that there are many other local companies not affiliated with ORLEN that employ foreign workers, and the company cannot be held responsible for such workers. The Contractor assured that the actions taken by CHT are in compliance with the law and applicable Polish regulations.
3	The benefits of the investment for the residents	One of the residents asked for clarification on how the local residents will benefit from the developed investment.	Director Damian Olewnik responded that first and foremost the biggest benefit would be the new jobs already being created. A new road will be built along with bicycle paths in the Biala-Dziarnowo-Draganie section of the village. ORLEN made a donation of 142 million zlotys for road investments to the budget of the municipality of Stara Biala and for Plock. There will also be an increase in the amount of taxes paid by ORLEN to the municipality once the investment implementation begins. The investment will support the Stara Biala municipality with a higher budget. Director Jakub Zgorzelski added that a donation agreement has been signed with Hyundai Engineering & Tecnicas Reunidas for the renovation of Zglenickiego Street, which is the main access road to the project site, and is also used by local residents. In the coming weeks, more donation agreements will be signed for local authorities, both for Plock and neighboring municipalities.

At the end of the meeting, the head of the Stara Biala municipality, Slawomir Wawrzynski, stated that the municipality has not noted any problems with the Olefins III Complex construction. The local police force ensures that order is maintained. The municipality, in consultation with priests, organizes additional masses in order to provide the greatest comfort to residents and to allow foreign workers of Christian faith to fulfill their spiritual needs. The municipality is in constant contact with ORLEN as well as the contractor Hyundai Engineering and Tecnicas Reunidas.
